- 2. Trustees reviewed invoices, signed checks and vouchers, reviewed and initialed payroll, reviewed and signed purchase authorizations.

Financial/Administrative: (Fiscal Officer's report)

- 1. A reallocation will be made of \$54,000 from ARPA Fund, Repairs/Maint 2273-120-323-0000 to Machinery/Equipment 2273-760-740-0000 & issuance of T/N PO for \$53,853.25 to Stryker for power load/cot system as approved 1/17/22 and 8/1/22 minutes.
- 2. Motorola (radios) expense will be proportionately divided between fire and EMS budgets based on number of units assigned to each. Then and now Purchase Order to be issued for the total of \$195,176.06 to Motorola Solutions with supplemental appropriation approved on motion by B. Haar and seconded by DJ Greenhill. **Motion carried.**
- 3. T/N PO approved to be written to Huntington Bank for the December backhoe lease payment of \$19,505.26, with allocation between principal and interest for Road and Cemetery Funds as previously approved, 40/60% respectively between the funds.
- The Wolf Creek Petition Project #143 has been dismissed by Sandusky County. B. Haar moved and Greenhill seconded that \$878.95 of assessment costs incurred be paid in 2022. Motion carried.

- 5. Greenhill moved and B. Haar seconded paying the Bureau of Workman's Compensation annually and to issue supplemental appropriation as needed. **Motion carried.**
