The minutes of the regular meeting held January 16, 2023, were read by Chairman Beverly Haar. DJ Greenhill motioned and Jerry Haar seconded that the minutes be approved. **Motion carried.**

FINANCE

1. Trustees reviewed invoices, signed checks and vouchers, reviewed and initialed payroll, reviewed and signed purchase order/blanket purchase orders.
2. A motion was made by Trustee Greenhill and seconded by Trustee J. Haar that the attached list of bills totaling **\$41,427.82** be approved as the lawful obligations of Harris Township and that the Fiscal Officer be permitted to issue warrants in favor of the same. **Motion carried.**

Financial/Administrative: *(Fiscal Officer's report)*

1. OTARMA risk audit is scheduled for Monday, February 13 at 9 am.

Zoning: *(Inspector's report)*

1. The Zoning Commission and Zoning Appeals Board will have organizational meetings on Tuesday, February 7.
2. Mark Messa's corrections of the zoning resolution revisions have been received and will be reviewed by the zoning commission.

Cemetery: *(Sexton's report)*

1. The OSS Aim to Be Green recycling reimbursement grant has been awarded for \$3,695. B. Haar motioned and Greenhill seconded the purchase of an electronic announcement board for the recycling area. Fiscal Officer requested that the purchase not be made until permanent appropriations are in place in March.

Roads: *(Road Superintendent's report)*

1. The John Deere long reach mower has been repaired in house which was determined to be low transmission fluid.

2. Greenhill moved and J. Haar seconded purchasing plow skid shoes for the plow truck and a cutting blade for the Freightliner. **Motion carried.**
3. The Fire training trailer is to be removed from the property next Saturday.

EMS/Fire: *(Chief's report)*

1. Two metal buckets, costing \$28, were purchased for a recent fire.
2. Volunteer firefighter resignations received from Eric Fulwider, Glenn Sasscer, and Bradley Gilbert.
3. An area HAZMAT drill will be hosted by HEFD at the station on February 25.
4. The annual appreciation dinner will be held Saturday, March 4.
5. The 2021 AFG grant award has been extended by FEMA until March 21. HEFD is still in the review process for a tanker truck. Re-submission of grant application may need to be made for 2023 prior to knowing award status.
6. Fire personnel volunteer pay scale has been tabled.
